- 5. <u>User(s) of Compound assume all risks and liabilities for all occurrences.</u> Windjammer Village <u>carries NO Insurance for any loss or liability or any other coverage.</u> Users agree to these risks.
- 6. Compound Key may be obtained after satisfaction of all requirements for a one time refundable \$100.00 (one hundred) dollar deposit. This deposit is required for all approved users, regardless of the length of stay. In the case of a lost key, no deposit is refunded, and an additional one hundred dollar deposit is required to obtain another key.
- The Compound is for your convenience and is for neatly approved storage items only. This
 is <u>not</u> a junk yard or dumping ground. All users of this compound are required to maintain their
 area, keeping assigned area free of debris, litter, tall weeds, etc.
- 8. Windjammer Village will remove or tow any item(s) stored, vehicle, vessel, trailer, etc. at the resident or owners expense that is in violation of any of our rules and regulations, or the State of Florida or Collier County; resident/owner will be responsible for this expense, and shall pay all reasonable attorney fees and all other fees and costs incurred by the Association. The Association is <u>not</u> responsible for any damage/loss of property in compound, toed, moved or removed from property.
